Date appealed letter was prepared on 2/24/2023.

Responded Received from Appellant 3/2/2023.

Respondent called numerous times, the court of Orangeburg and Columbia Court of Appeal to inquire about date and was told no such case was filed.

May 1, 2024 at approximately 3:40pm, Harry Gadson/Brandy called the court of appeals and was informed by Ms. Becky to write a note to Ms. Jenny Kitchings asking her to check the status of the appellate case between Gadson and Goodwin. Ms. Kitchings was sent a certified letter on May 28, 2024 and enclosed was asking her to check into the status of the case and in addition also enclosed was a copy of the appealed letter received from appellant Goodwin dated March 2, 2023.

I, Harry Gadson, received two (2) letters from the court of appeals. Letter dated June 4, 2024 and June 22, 2024.

Appellant Goodwin stated he did not receive the letter dated June 4, 2024 until June 27, 2024 and at that time he was advised that the appeal was **IMPROPERLY** filed by the court. Appellant Goodwin's appeal was NEVER filed with the court system in Orangeburg or the appeals court in Columbia, SC. If you were to check your records you will find that the appeal was sent in my certified letter to Ms. Kitchings on May 30, 2024. Not before that date of May 30, 2024 was this appeal filed in any courts within the state of South Carolina. The appellant Goodwin prepared this appeal on February 24, 2023 and as of May 2024 which is a difference of 15 months, you still have **NO EVIDENCE** of this appeal being filed except what was sent in by me, Harry Gadson.
