To whom it concerns,

My name is Louis Hall Jr. and I have been a friend of Brother Don Adair and a member of the Salem Association since 2009. My wife and I spent about 3 weeks with Brother Adair and his wife Sister Marilyn Adair to have in depth studies at that time. We frequently exchanged phone conversations for years before my initial visit with the Adairs. We were good friends before his current medical condition took place.

I have been on the ground to witness Judy's treatment of Brother Adair -which has been great, his living conditions before and after we got involved, and the progression of his disease. I helped my wife find a new place for him to live and many other things.

I also know how the Davidian world works and who's who.

Trevor Bingham has never been a friend of Don Adair's -he's actually the leader of a different Davidian organization for years and is seeking control of Brother Adair for religious clout and to take members of Brother Don Adair's organization for years. Brother Adair constantly fought against his father's teachings, M.J. Bingham, warning all who would listen about his false doctrines. Brother Adair also contended for his entire tenure as vice president that the Davidian association started by the Bingham's (Bashan in Exeter, Missouri) was false and illegitimate. Trevor Bingham is no friend of Salem or Bro Adair.

Jirair Baghdassarian on the other hand is just about an unknown to Brother Don Adair and to Salem. Brother Adair had one study with him 20 years ago and then he went off and started his own Davidian association or group. Brother Adair fought and taught against these independent groups his whole life. 

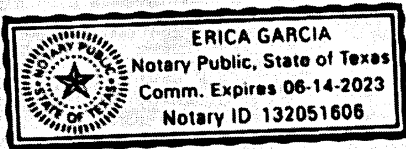

To Whom It May Concern,

I am writing on behalf of Judy Tupolo about helping Don Adair. I have known Judy since the early two thousand and Don and His wife Marilyn since the late 1990s through my ex-husband who was a member of their association at one time.

In 2010, even though my husband was no longer part of their association, when we got a call about their place burning, where they lost everything, we went over to see if they needed any assistance. I took Marilyn to get her medicine and a few items. (I only share this with you to share that I would check on them from time to time).

On Oct 15, 2018, Don Adair's wife Marilyn passed away after battling cancer. I did go by and see her at the hospice house.

I went by and checked on Don since he was an older man with no family. His place was in bad shape and filthy. He had a hole in the kitchen floor where a rat had chewed a hole and Don would feed the rat, so it would not chew any more holes in his trailer. I tried to reason with him about how we need to clean the place and fix the hole. I cleaned up some. He had rotten food in the refrigerator and the cupboards. He had worms in some of the food. I contacted Judy since she was a friend of the Adair's for many years. I was concerned about his mental state as well as his health. I could not come over every day since I worked and the distance of where I lived verses where he lived.

After Marilyn's death, her nephew Kevin Mueller popped over and would take carpenter tools and other items on the property saying Marilyn told him he could have them. Kevin and his dad Carl Mueller took Don to court trying to evict him from the trailer where Don and his wife were living before her death. Kevin and Carl Mueller would

come to the association property harassing Don about wanting money, and saying that Don had to leave the property because it belongs to them since Marilyn's death. They said Marilyn gave them the property. However, the property did not belong to Don or Marilyn, it belongs to the Salem General Association of Davidians. I did not want to get involved with family matters, but I felt uncomfortable of someone possibly taking advantage of a frail elderly person.

Judy is a retired Air Force Major Nurse who came out to help Don. She set up his doctor's appointments. She didn't to have to, but she been friends with him and his wife for over twenty years. She loved both Don and Marilyn. She felt called to help him out since he did not have any family members nor other association members willing to relocate to an isolated area to physically help him.

Don has been diagnosed with Dementia and Alzheimer's with vascular dementia. I have been trained, certified, and work with both since around 2015. I have come over on my days off work to house sit for Don so he could go grocery shopping and run errands. He was scared thieves, as he would say it, would come over and steal his things. I would come over about once a week. Most of the time I would stay in my car because I did not like the smell of the place, and it burned my eyes. I did try to clean up some. I was concern he would get food poison so I would throw away rotten food and outdated cans of food or other items. There were a few times Don got lost coming home. When COVID hit I suggested that I picked up items, food as well as make food for him. He did not like being able to drive to town, but I was concerned for him. I believed that if Don would get COVID it would be detrimental to him.

Judy and Don stayed with me a few months until she was able to get a place. I did not mind them staying. Judy wanted to get him out of that trailer as it was not a healthy environment. He was suspicious and often falsely accused my son of stealing his belongings which he misplaced.

Most of the people who are criticizing Judy's character has not even been to where Don was living and if they had, they should have done something to help. Don is not an easy person to deal with without medication. He can become paranoid, hallucinating (thinking his wife was up the road and that Judy was his wife etc...as well as being combative). It takes someone who has worked with Dementia and Alzheimer's patients who has had training. I believe Judy has been that person who is trained as a retired Air Force Major Nurse. She has taken him to the dentist, eye and doctor appointments etc. It saddens me how people can get. Some I believe are not really interested in Don's physical well-being, they are more interested in what they think he has that is valuable to them, like his published books, charts and Bible study records.

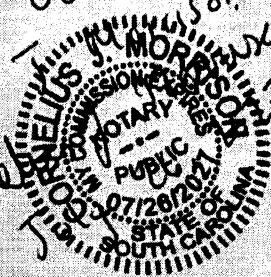
Judy is a very generous, kind and caring person. I've witnessed her giving him great professional care. Don is really blessed to have her as his caretaker.
