I just sent the Notice of Appeal in this case to the Court of Appeals. I believe that was in error as this is a PCR case I believe it should be filed in the Supreme Court.

Attached for electronic filing and service please find attached the Notice of Appeal and Certificate of Service in the case of Patrick Bertram Walker, #296176 v. State of South Carolina, 2022-CP-23-1759. This is a PCR case and my client is indigent. My representation does not extend past that of the filing of the Notice of Appeal. I have copied SCCID with this email and have forwarded Mr. Walker's affidavit of indigency to SCCID via email and the original via U.S. Mail. As I believe that Mr. Walker will qualify for SCCID services I will not submit an SCCA Form 800 to request the transcript in this case unless I am directed to do so by the Court or SCCID. The attached signed copy of the Amended Order of Dismissal was received via email from the presiding judge. I see where the signed order was entered by the clerk of circuit court on July 3, 2024. The clerk of circuit court did not upload the actual clocked copy to court records and therefore it is not available through the judicial website. If I receive a clocked copy of the Amended Order of Dismissal prior to my leaving I will forward it. If it is received while I am on secure leave I will forward it immediately upon my return. Due to my anticipation of SCCID involvement, other than forwarding the clocked copy of the Amended Order of Dismissal I will take no further action on the appeal unless instructed otherwise.
