1. Ineffective Assistance of Counsel

Violated my Fifth Amendment and my Fourteenth Amendment right- due process, by refusing to call vital witness that could have supported my claims. After been asked repeatedly to do so. . Had my attorney Subpoenaed my key witness the could have heard evidence to support my claim that the use of 501(3)C at the closing of said property was not that of the Plaintiff because of my attorney Negligent and Refusal to subpoenaed key witness that was parties involving in said property. The individual of said Organization, and the Organization Secretary which Charles Robinson, and CEO Joseph White these names were given to my attorney. My attorney refusal to call or question my witness damaged my case and might have resulted in a different verdict, because of attorney my Fifth Amendment and Fourteenth Amendment right was violate my him solely

Fail to contact witness through Via telephone to gather information (4) witness, Alfred Davis, Michael Bromell, Edith Frazier, Travis Durham, Thessa West, many other witness. Had my attorney spoke with me about other possible witness that could have to light my claim because of his Negligent my case was not properly handle

Because of my attorney refusal to communicate with me via telephone or email. I placed numerous phone calls to his office, left messages with paralegal and secretary my attorney wouldn't return any of my calls. I phone one month to confirm hearing date my attorney didn't return my call with information until one week prior to hearing not given my witness efficient time to schedule appears. My attorney malpractice and negligent of my case violated my fifth and fourteenth Amendment rights.

My attorney was given court documents of prior case involving the Plaintiff fraud involving Trademark which my attorney refusal to gather information. at the time my property was given. Had my attorney subpoenaed my key

witness Charles Robinson of Gate of Heaven and Joseph White the CEO of CLGI, these facts could have impacted my case because of his Malpractice my case damage and Compromise

My attorney also personal relationship with the Plaintiff attorney which was conflict of interest, was seen having lunch during the my hearing

Counsel refused to file appeal after verdict, which he stated during consultation that will be my option, which all so violates my right to due process

Quit on my case 3 days after the hearing because I desire to exercise my right to appeal, which also violates my right to due process.

Did Not working the case until days before the hearing, 1 week prior to my hearing my attorney phone trying to do a rush job because of his Negligent/ mishandling my case suffered

Did not prep client for hearing. Had my attorney prep myself and one witness that just happen to show up, we could have been prepare for questioning due to his Malpractice my Fifth Amendment was violated

Was very hostile and rude and argumentative at times very disrespectful not willing to listen. Not wanting me to exercise my right to be hear in the court of law, had his own agenda, had my attorney was open to explore different avenues for my case could have been favorable

Got detail from one witness during a 5min break, not efficient time to go over witness statement, because of my attorney negligent my case not get the attention it was warranted
