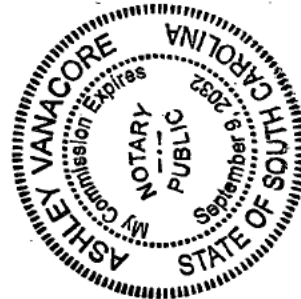
7. Appellant, Tucker; states the Department of Corrections (SCDC) owes him approximately \$ 120,000.00 of prevailing wage.

Dear Judge Anderson:


