counsel missed the filing deadline in this matter.


2. Counsel's wife suffers from post polio syndrome and has otherwise been in poor health including severely restricted mobility. She experienced a decline in her condition during the months of July and August, 2013, and counsel was required to devote substantial attention to this matter during this time. When the transcripts were delivered to counsel's office by the court reporter on or about July 19, 2013, counsel inadvertently failed to note receipt of same on his calendar and subsequently failed to notify this Court and opposing counsel that the transcripts had been delivered. Appellant Babb delivered a check to counsel's office for payment to the court reporter for the transcripts and even with that payment, counsel did not record receipt of the transcripts themselves on his office calendar. Thus, counsel's error was not attributable to the Appellants personally, but lies wholly due to counsel's oversight in this matter.

3. Counsel has spoken to opposing counsel, Frank N. Durant, Esquire, about this request (although not about the reasons for counsel's error) and while sympathetic Mr. Durant has been unable to consent to this request.

WHEREFORE, Appellants would respectfully request an additional thirty (30) days in which to serve and file the Initial Brief of Appellants.


