MOTION FOR AN EXTENSION TO SERVE AND FILE
THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for William Craig Caughman respectfully requests a **final thirty (30) day extension from July 17, 2024 until August 16, 2024** in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for William Craig Caughman respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the Brief of Petitioner in the case of DeAngelo Brown v. State with the Court of Appeals on June 20, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Ben Robert Stewart v. State with the Supreme Court on June 3, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Jerry McKnight v. State with the Supreme Court on May 29, 2024.

4. Counsel makes this request in good faith and not for purpose of delay.


5. On June 26, 2024, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through July 31, 2024.
