
Dear Mr. Bankhead, Ms. Dennis, and Ms. Simplice:

- The appellants' initial brief must contain a table of contents and cases, statement of issues on appeal, statement of the case, standard of review, argument, and conclusion pursuant to Rule 208(b)(1), SCACR. The appellant's initial brief must be substantially in the format shown by Form 13 in Appendix C to part II of the SCACR.
- The appellants' initial brief must be double spaced pursuant to Rule 267(c), SCACR.
