2. Counsel for appellant respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions


previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Latavious Williams with the Court of Appeals on June 28, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Emanuel Williams with the Court of Appeals on May 29, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Kari K. Ryant with the Court of Appeals on April 17, 2024. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Vance Ross v. State with the Supreme Court on March 18, 2024.






