This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed today.
2. Counsel filed the Brief of Petitioner in the case of Ronnie C. Swofford v. The

State with this Court on July 22, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Travontae Mitchell with this Court on July 17, 2024. Counsel filed the Petition for Writ of Certiorari, the Brief of Appellant Pursuant to *White v. State*, and the Appendix in the case of Gerald Akeem Gadsden v. The State with the Supreme Court on July 8, 2024. Counsel filed the Brief of Petitioner in the case of Maurice Roberts v. The State with this Court on June 27, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Morgan Dayle Carr with this Court on June 21, 2024. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals in the case of Brittnay C. Foster v. The State with the Supreme Court on June 3, 2024. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Montre D. Brown v. The State with the Supreme Court on May 31, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Marcus D. Batson with this Court on May 22, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Antonio Long with this Court on May 17, 2024.


3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

4. On June 26, 2024, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through July 31, 2024.


