extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.


3. On July 25, 2024, counsel filed the return to the petition for writ of certiorari to the Court of Appeals in The State v. Mark A. Hailey, Jr. with the Supreme Court. On July 24, 2024, counsel filed the petition for writ of certiorari and accompanying appendix in Corina Castro v. The State with the Supreme Court. On July 17, 2024, counsel filed the petition for rehearing in The State v. Paulette Sims with the Court of Appeals. On July 16, 2024, counsel represented the applicant at his PCR hearing in Artrell Hickson v. The State before the circuit court. On July 12, 2024, counsel filed the initial brief of appellant and designation of matter in The State v. Che Ransom with the Court of Appeals. On July 11, 2024, counsel filed the petition for rehearing in Michael Orlando Brown v. The State with the Court of Appeals. On July 10, 2024, counsel filed the brief of appellant and designation of matter in The State v. Marquis Brown with the Court of Appeals. On July 3, 2024, counsel filed the initial brief of appellant and designation of matter in The State v. Jasmine Robinson with the Court of Appeals.

4. Counsel makes this request in good faith and not for purpose of delay.


5. On June 26, 2024, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through July 31, 2024.

WHEREFORE, the undersigned counsel would respectfully request a **final thirty (30) day extension until August 30, 2024** in which to serve and file the Petition for Writ of Certiorari and Appendix in this case based upon the above exigent circumstances. Counsel requests that time limits for filing the Petition for Writ of Certiorari and Appendix be held in abeyance pending a ruling on this motion.
