When a true adversarial criminal trial has been conducted even if defense counsel may have made demonstrable errors the kind of testing envisioned by the sixth amendment has occurred. But if the process loses its character as a confrontation between adversaries the constitutional guarantee is violated. Effective assistance of counsel requires the attorney to exercise reasonable professional judgment to take such steps as a reasonable attorney would take to prepare for trial to reasonably represent the defendant's interests at trial and post-trial proceedings and to do so without a conflict of interest. An attorney's lapse in providing assistance does not render the representation ineffective unless either the failure was reasonably probable to have affected the outcome of the proceeding or the failure was so patent and likely to... the outcome that it isn't worth a hearing to determine that... Occurred. Thus stated I am concerned about counsel representation meeting an objective standard of reasonableness, in addition to it passing the "Strickland" test. Subsequently sponsoring this inquiry for counsel to provide *Effective* assistance.

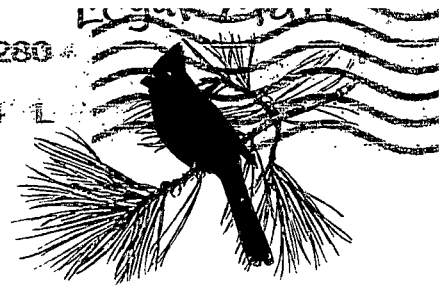
