I am writing asking you the status on my appeal that were sent to your office from the clerk of clerk in Florence County.

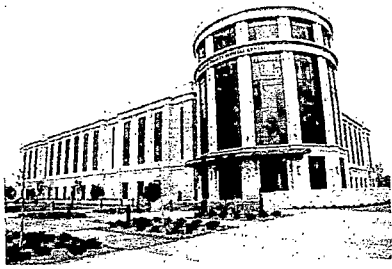
