An Amended Brief of Appellant (the Initial Brief) was also filed and stamped by the Representative of the Courts on **June 24, 2013**


The Appellant filed and had stamped the Initial Reply Brief of Appellant by the representative of the Court of Appeal on **July 19, 2013**


