To the South Carolina Court of Appeals:

My name is Kenneth M. Pace, Jr. I am writing this letter to the South Carolina Court of Appeals as a humble motion and request to reinstate my appeal for the decision given me from the South Carolina Administrative Law Court on May 31, 2024.

I originally made the request and sent proof of service to the South Carolina Administrative Law Court certified mail on June 20, 2024. My tracking number slip verifies it was delivered to its destination on June 24, 2024. This was within the window of the deadline (May 31, 2024) for the notice of my appeal to the South Carolina Administrative Law Court. Unfortunately, there was a discrepancy on the proof of service I sent. I was made aware of this discrepancy by the South Carolina Court of Appeals by phone, then later by a letter dated July 9, 2024. The letter from the Court of Appeals granted me 10 days to correct this mistake. However, I did not wait for the letter, I corrected the issue and resent the proof of service notice to the South Carolina Administrative Law Court before the correction deadline was over both via email and certified mail. I have all the certified receipts from the USPS, as well as copies of the emails sent to both the Administrative Law Court and the Court of Appeals to corroborate my efforts in this matter.
