**MOTION FOR THIRD EXTENSION OF TIME TO FILE
INITIAL BRIEF OF RESPONDENT AND DESIGNATION OF MATTER**

The undersigned counsel would respectfully request a THIRD thirty (30) day extension in which to file the Initial Brief of Respondent and Designation of Matter in the above-referenced case. The Initial Brief is currently due to be filed Friday, August 9, 2024. Counsel for Appellant has graciously consented to extension requests up to and including August 31, 2024. In support of this motion, counsel would respectfully show the Court the following circumstances:

Respondent has been unable to complete this brief because the undersigned attorney has had a number of other state, and federal matters to attend to since July 8, 2024 including matters in this Court. Specifically:

1. Counsel filed the Respondent's Reply to Response to Motion for Summary Judgment [ECF #51] in the matter of Steven W. Oxendine, #383737 vs. Warden of Evans Correctional Institution, C/A No. 2:23-00160-SAL-MGB on **July 8, 2024**;

2. Counsel filed the Respondent's Reply to Response to Opposition to Motion for Summary Judgment [ECF #53] in the matter of Steven W. Oxendine, #383737 vs. Warden of Evans Correctional Institution, C/A No. 2:23-00160-SAL-MGB on **July 12, 2024**;

3. Counsel prepared and filed the Initial Brief of Respondent in the Marion County murder (2 counts)/weapons possession appeal matter of State vs. Isaac Kareem Hemingway, Appellate Case No. 2023-000408 which is currently pending in the South Carolina Court of Appeals, which contained five (5) issues, and Respondent worked on this brief almost exclusively for four (4) and one-half ½ weeks and the Brief of Respondent was 62 pages in length, and same was filed on **Friday, July 12, 2024**;

4. Counsel prepared the Reply to Response in Opposition to Motion for Summary Judgment [ECF #29] in the matter of Arthur W. Macon vs. Bryan Stirling, et al., C/A No. 0:24-185-HMH-PJG on **July 29, 2024**;

5. Counsel assisted in the preparation of a murder trial, State v. Devonte Page, on July 22, 2024, to be conducted in Dillon County, on July 29, 2024, prosecuted by the Attorney General's Office;

6. Counsel also filed the Reply to Objections to Report and Recommendation [ECF #63] in the matter of Jon W. Jarrard vs. Warden Wilfredo Martell, C/A No. 5:23-cv-2588-SAL-KDW on **August 2, 2024**;

7. Counsel is currently working on the Return and Memorandum of Law in Support of Summary Judgment in Michael Young v. Warden, a federal habeas matter, where the petitioner was convicted of murder and ABWIK and no further extensions are permitted. Same is due to be filed **August 16, 2024**;

8. Counsel is currently preparing the Initial Brief of Respondent in the matter of The State vs. Anthony Nicholas Argoe, Appellate Case No. 2023-000223, a Dorchester County direct appeal matter now pending in this court;

9. Counsel is currently preparing the Initial Brief of Respondent in the matter of The State vs. Antonio D. Brayboy, Appellate Case No. 2023-001182, a Florence County murder appeal matter now pending in this court;

10. Counsel is also currently preparing the Response to Objections to the Report and Recommendation of the Magistrate Judge in Malcom Williams v. Warden (Federal Habeas Corpus);

11. Counsel prepared the Reply to Response in Opposition to Motion for Summary Judgment [ECF #27] in the matter of Calvin T. Williams vs. Warden of Perry Correctional Institution, C/A No. 9:24-cv-457-JFA-MHC. Same will be filed on Friday, August 9, 2024; and

12. Counsel has been involved in working **on other matters in state and federal court**;

WHEREFORE, for good cause shown, counsel respectfully requests a third thirty (30) day extension of time to serve and file the Initial Brief of Respondent and Designation of Matter. This request is made in good faith, and not for the purposes of delay. This extension will make Respondent's Initial Brief due September 9, 2024.
