

Counsel for Appellants above, hereby respectfully moves the Court pursuant to Rule 224, SCACR, to reopen the Appeal and provide this supplement to its motion filed on August 26, 2013. Appellant failed to file with the Court the proofs of service for the letter of notice to the Workers Compensation Commission and the letter requesting the transcript. This was an oversight which occurred at the same time. 




