In the following regards: ① I am appealing this 3/28/24 administrative hearing because Administrative hearing officer Did not consider the fact the charge was to be dropped, there's (no victim) prosecuting officer Darrien m. Roseau was fired, criminally Indicted, and arrested, and none of the paper work had my name on it for me, and it was admitted 2:30 hrs. my wife was in north Carolina (NOT) South Carolina [9:30 pm and on 2-20-24 hearing in front Judge John Kennedy Melton AS He called for fired criminally Indicted officer Darrien m. Roseau my wife told (Magistrate John Kennedy Melton) she was not in this State at the time Alleged 2:30 hrs. But in North Carolina Drive time to get a vehicle this is on record of preliminary hearing transcript (you can't get probable cause for an Alleged crime if the person was not there. ② I was blocked by Jailers to contact my witness which could have changed the outcome of this hearing I represented myself and had the rights of an Attorney Chesterfield County Jailers etc. Topeka Foster and others denied me to call my witness Interfered with my Administrative hearing 3/28/24. ③ State v. Ramsey, 673 S.E.2d 428, 381 S.C. 375 (S.C. 2005) clearly states Reversal and Remand) Magistrate had No Authority to have probable cause hearing should've declined it (this didn't happen with me either and should have declined, see section 43--232 of code: Jurisdiction statute: Court of General session has no Jurisdiction of case At the time of Indictment, Actions of A Court with respect to A matter, as to which it has NO Jurisdiction is (VOID) the court without Jurisdiction the Indictments is Nullity, see 16-25-20: S.C. the offense must be tried in Summary court and the magistrate had No Jurisdiction to hold Probable cause hearing on charge. ④ 4-1-24 a secretive hearing was had by Judge Paul m. Burch and No Revocation order was there to be signed off on by me (or) him the transcript with this hearing is proof Probation Agent MARK funder burk didn't have the paper work at all and to place me in prison

Burch on (4-1-24) (But) the original date for the hearing was to be held (4-4-24) I WAS given this Notice A secretive session WAS Held With Judge paul m. Burch I WAS UN AWARE of the out come of this situation which could've changed I illegally transfered to SDC Denied to Recieve a legally signed Copy of A Revocation order with my name signed and dated (OR) any Judge as a witness same date for Appeal purposes It's Either forged by probation Agent Janie meyers (OR) She falsified and lied with Agent MARK funderburk on the order which she was not to Even have this order In her hands E-pod camera shows she came to get me to sign it Escorted by ofc. Conley whom made (Reihlowens) get me the shower I was housed In cell E-4 E-pod.
