On June 6, 2023 at 10:00am in your court, my father's estate will be discussed & decided upon.

Since I plan to attend and state my objections regarding Laverne Smith and Alyiah Palmer receiving any portion of my father's estate, I have been caused a great deal of harm, physically, mentally and emotionally.

I've been caused harm for other reasons other than my dad's estate. I've been caused harm by the police/sheriffs deputies, the VA & Sen. Graham's Office after requesting a Congressional inquiry for various breaches against the VA, FBI and other Govt agencies. My nephew-Scottie Bathers, (1985) threatened me and I also believe Laverne Smith & her daughter (TRIA) are also the culprits. An incident on Friday May 12, 23 at The Shell Gas Station on Congress where I was called a prostitute and harassed, after police were called to my sister's home a black female pretended to be talking on the phone to someone she mentioned by name (LEAH) the same as my niece, whom I'm objecting to receiving any portion of my father's estate. I attempted to get a subpoena for the video to have you view. I was unable to do so and told to ask your court.

I believe I've been given some of the medications, from a list of BP meds printed out for Sen. Obama's office (which have harmful & severe side effects, some causing memory loss, confusion and psychotic behaviors - view enclosed LIST). I'm NOT on medications of any kind and should not be given any. This was done before & after the request. The police/Sheriff's Dept. have caused a great deal of problems for me since I've been here in South Carolina. I've had to go to them to file police reports regarding harm I've been caused. They refuse to take reports, to take accurate reports and/or to investigate. They try to make me look like the criminal instead of the victim. I'm constantly at the Police Station ~~re~~ correcting reports, one in particular where Sgt Jones stated I told him I always carry a knife and a gun. I do NOT own a Gun. I do however have a legal size knife. That's mainly kept in my glove compartment of my car. This was done after I planned a peaceful protest at the State House. I feared I would be shot and delayed the protest. I've had to file multiple complaints with the FBI, IA and I believe these things are being done in retaliation. They've forced my bank acct to be closed not presently but in the near future.

I pray I do not need to request a continuance on that day, but if I do, I pray the court will grant it.

I also believe that the hotel I've been staying in, where my rights are being violated, has something to do with the drugging since they have access to my food + drinks stored there as well as by other means. Any and all assistance you can give will be greatly appreciated.

A mediation hearing was scheduled on May 31, 2023 at 10:00am. I was allowed to attend but was excluded from any of the decision making process of am totally in the dark as to what transpired between the two parties involved, but was told they could present any <sup>mediation</sup> agreements to you at the upcoming hearing. Agreements that I am unaware of. I was not allowed to sit in on any of the negotiations (although I requested to do so) or to know of the outcome. I verbally stated my objections at the beginning to the mediator, which was to keep Renee's contest (as is), with the exception of my niece being an heir or the portion of my Dads estate. If she could not be excluded. Mr. Parker and my sister, listened to more detailed objections from myself and then had me sign an agreement to mediate document that I was told everyone had to sign. The document states Renee Palmer vs Janet Palmer-Carri. It was difficult to read + understand because of an ongoing conversation between my sister + her attorney. I had to excuse myself for that reason and try to understand what I was signing. I asked Mr. Parker for Clarify before signing and was told everyone signs the same thing. (NOT like my position was to keep everything as is in Renee's contest but I stated I wanted to hear what was being decided upon. I was not allowed to do so. I do not believe Mr. Parker, my sister's Attorney had my best interest at heart nor did the mediator, who to me, used intimidation tactics, in order to get us to mediate. His name Mr. Thomas Lydon of M&C LAW FIRM. I sat at a 4-hour mediation and at no time did anyone advise me of what was transpiring! I was however told that a member of my family and his girlfriend, who were drug abusers, overdosed and that the funeral was Saturday. I thought this to be an odd time to bring this up and under the circumstances I grew a bit suspicious. At the end I told Mr. Lydon, Mr Parker and Renee that she wanted to mediate with

With her portion she was welcome to  
but not from my share. I asked if  
this affected me and the original contest  
I was told no.

I am requesting a postponement of  
the case hearing scheduled on June 6, 2023  
at 10:00 am so that I may retain a  
lawyer who I believe would have my  
best interest at heart not just my sisters.  
Something I attempted to do initially  
but was prevented from doing so for a  
number of reasons. ① My sister said she  
had my best interest at heart and since  
she had a lawyer I didn't need to get one,  
② My cell phone which was hacked prevented  
me from taking care of any business  
including the business of retaining a lawyer  
and ③ after bringing this to the attention of  
the probate clerks in the court I was  
advised to just wait and see what  
happens. I have been having some  
issues with my present phone, especially  
in the hotel room I'm renting at the  
Executive Inn in Ridgeway but unfortunately  
it won't hinder me from getting the  
legal assistance I need or anything else.  
I'm requesting a 2 month delay. If an  
attorney is found at that time, he can  
handle my legal matters.

I believe the court should not allow this to move forward until I have a chance to be properly represented and this case is brought before an ethical judge to render a proper decision. Initially, while attempting to get legal assistance, my phone was hacked and attys declined for one reason or another. My sister told me not to get an attorney, because she had one and that he's looking out for our best interest, since she was contesting and naming herself, me and my niece as heirs, after seeing this in writing I agreed, with the exception of my niece. After given paperwork from Mr Parkers office that I believed required a response within 30 days, I sought legal assistance again, unsuccessfully. I then went to the court and stated the problems I was having w/ my phone and retaining a lawyer. I was told to wait by the clerk and her supervisor Ms. Elrod. I believe the clerks name was Asper - (she sits at the first booth). I told them about the 30-day response they said to wait and see what happens. So I did. on the court clerks + Supervisors advice. I was given Judge Bettors phone number by my Aunt by marriage, Henrietta Palmer, she claimed she had conversations

with the Judge (Belton) regarding my  
dads will, me + my sisters. She  
asked if I would be okay with

yes initially, but since my oldest

attempted to call Judge Belton but  
was never able to get through to her,  
her daughter stated she was out of

were using my dad as a "Cash Cow".

The Court is preventing me from getting fair treatment as well.

I was lied to by probate court clerk ~~A~~ Wells McElveen who claimed my request for continuance was granted and the appeals court clerk gave me one page of two page appeal document and said it had to pay a \$150 fee.

The lawyer said said it couldn't be appealed then said there's a way but it wasn't worth it and when I looked on line it said a mediation agreement can't be appealed. What's going on?!

I went to Mr. James P. Snell Jr on July 3, 2023. Prior to my consultation, Cattland and a paralegal there who I explained everything in detail told me it could be appealed. And that the consult fee would be \$350. I asked if I could get it cheaper as a disabled vet she said NO. Then Cattland requested I make a card payment over the phone before she could make an appt. She became argumentative & confrontational when I asked why before services are rendered. Then said maybe I should find another firm. Desperate to get legal assistance I agreed to come in and pay vs giving my card over the phone. How did she know

That Harvard Grad w/ his fancy office cor'ed me out of \$350. His receptionist said he would take the case and he declined saying I need a probate atty to contest.

In My Dads will I was addressed as Janice Palmer my name is Janet Palmer-Carri, who is Janice Palmer. She apparently lives in SC I found that out when I went to vote. I know she's in richland county.

Someone doesnt want me to fight this I'm being lied to and manipulated. How can a girlfriend get more than a daughter-in-law and an Uncle, Aunt & Cousin get more than all of us, they live in the same household. His estate assets is not accurate. and why isnt his girlfriend in jail for signing checks in his name? She's Not a wife? Did the laws change? I was attempting to have his assets investigated before this. I wasnt told until the mediation

My father had dementia - incapable of making a wise rational decision.

He would have never put a no contest clause in his will - the will was done in a drugstore/hardware store not taken to a lawyer to protect my uncle Bobby Palmer, Henrietta Palmer, Michael Palmer, and Laverne (his GIRLFRIEND).

That's not my father's signature. I worked for him and I'm familiar with his signature.

The Judge (Judge Belton) had multiple conversations with Henrietta Palmer + Renee Palmer. I was given the Judge's phone number by Henrietta Palmer to call her. I called her daughter, answered and said she was out of town to call back. Luckily, I was unable to connect with.

on me and I was forced to leave. The

I was told to wait by the courts and by my sister Renee and look where we are now. An Unfair, Biased, Unethical Decision having been made.

I was taken advantage of, lied to by the courts and family and caused harm when I attempted to fight, as is the case with other court cases.

Someone has been and continues to strip me of everything I put before the government. (The VA + other Govt. entities).

Discriminated against, never given due process, and never allowed legal help always forced to represent myself. How can this be. I am a 100% Service-connected disabled veteran - does that mean anything in America? The country I served.

There were approx 2-3 wills. One unsigned and I'm referred to as Janice Palmer. That's not my name.

There is a Janice Palmer in SC (and other states) in or near Columbia. I found out when I went to vote but was not allowed because I wasn't registered 30 days prior to the election.

I am a victim of ID Theft. and I've been experiencing some of that down here in South Carolina.

It's hard to believe my family doesn't know my name or how to spell it.

A copy of the will was sent to a closed PO Box in California. Why? when they were told and knew that I now reside in South Carolina.

The VA also sent checks and other documents containing my <sup>personal</sup> information to this closed PO Box in California. why?

I believe the Government is involved, the VA, & other Govt agencies, possibly the Police, because of my opinions and or views, on political matters and the degree of my so-called influence & recent protest at the state House.

I am and have been targeted for years. When does it end?

I believe the mediation agreement was accepted to prevent me from going before the Judge (Judge McCulloch) on June 6, 2023 to state my objections & reasons why.

I was going to tell the Judge I believed my father's estate should only be divided between me and my sister Renee, and that it should not be divided equally because, my sister Renee has a house of my father's, which she has lived in since she was 17 and is now 63. So for 46 years she's lived mortgage & tax free (rent-free). I believe the only bills paid by her were utilities.

My sister Rosetta was his step-child. She's not his biological daughter nor was she legally adopted. My father bought and paid for a house in NJ for my

mother but my sister moved in and he cut my mother off financially. He believed my sister should be on her own since she worked for him and made good money. She lived there with her son for approx 25-30 years rent free. Rosetta Williams + her son.

My niece, whose my deceased sisters child should not be entitled to anything. She is a granddaughter not a daughter and he had other grandchildren. The laws should be changed to protect his daughters. I believe the remaining siblings should inherit the ESTATE.

Renee Palmer + myself. Janet Palmer-Carr. another reason I am against my niece is because my mother was suicidal because of her + she had to be put in a foster home, for my mothers sake. I had to listen to her threats of suicide.

Imagine, just imagine, how I felt. My mother was raising my niece.

My Uncle Bobby Palmer, my Aunt Henrietta Palmer (his wife) and my cousin Michael Palmer (their son) should not be allowed any portion and especially not more than his daughters when it comes to my fathers estate.

During mediation I was made aware of the fact the Bobbi + Henrietta were given (either \$10,000 ea or \$10,000 together.) a portion of the sale of one of my father's assets - a strip mall in Blythewood sc.

I am writing to request that Judge Belton's decision be overturned. My name is Janet Palmer-Carri, I am a disabled veteran, whose been taken advantage of just like my deceased father. <sup>who had dementia</sup> I moved to SC on Sept. 29, 2022 <sup>moving to</sup> and we lived her ever since. Prior to SC ~~moving here~~ I was surviving in hotel rooms in California. Basically, I was homeless.

My sisters & I were estranged due to there changing their phone numbers as well as changing my dad's so I had no way to contact them. My only contact was my son + his dad, who didn't have their numbers either. When my dad died I was notified by my son who got a call from my <sup>older</sup> sister. I was in the process of relocating due to 7+ years of suffering in California. I drove to SC to ~~my dad's~~ funeral attend my dad's funeral. It took me 4 days of driving with minimal sleep, and I still didn't make it.

The family had cut me off for reasons unknown to me. My sister ~~Cherene~~ changed her number, they changed my dad's number and I had no way to contact them. I was attempting to pursue my singing and/or acting career. Upon hearing about my dad's death, I drove to SC,

It'd say that's a big charge.

I requested an ~~extension~~ postponement of a upcoming court date and was told by Mr. McElveen - court clerk that it was granted and in the mail they tied. I no longer had 2 months to find an attorney apparently the case was decided and not by Judge McCullagh by Judge Betton and friend to the defendants. I believe her decision was BIASED and should be thrown out.

I also believed my fathers estate was misrepresented financially. I believed he had much more than was documented. I attempted to ~~handle~~ hire @ Stillinger Investigations they said wait till after the case is over. but then this happened.
