

BURGLARY, FIRST DEGREE

The defendant, William David Gunn, did on or about April 18, 2023, in Oconee County, South Carolina,, willfully and unlawfully enter the dwelling of Toby Honea Bryson Shaw located at 204 Johnson Drive, Walhalla, SC, without consent and with the intent to commit a crime therein, and when, in effecting entry or while in the dwelling or in immediate flight, he or another participant in the crime: is armed with a deadly weapon or explosive; and/or causes physical injury to a person who is not a participant in the crime; and/or uses or threatens the use of a dangerous instrument; and/or displays what is or appears to be a knife, pistol, rifle, shotgun, machine gun, or other firearm; and/or the burglary is committed by a person with a prior record of two or more convictions for burglary or housebreaking or a combination of both; and/or the entering or remaining occurs in the nighttime. All in violation of 16-11-0311 of the South Carolina Code of Laws (1976) as amended.






