

YOU WILL PLEASE TAKE NOTICE that the Respondent hereby moves for an Order for Extension of Time to file and serve Respondent's Final Brief. Respondent needs additional time because Appellant has failed to perfect the Record on Appeal. A letter from the South Carolina Court of Appeals dated August 14, 2024 indicates that Appellant filed a Motion to Supplement the Record on Appeal (even though the undersigned has not received a copy), and the deadline for Appellant to comply is August 24, 2026 (which would fall to August 26, 2024 since this is a weekend day).
