On Tuesday, August 13, 2013, counsel filed the petition for writ of certiorari and accompanying appendix in Anthony M. Brown v. State. Counsel filed the brief of petitioner in the case of Stanley Wise v. State on Friday, August 2, 2013. Also on Friday, August 2, 2013 counsel filed the Anders brief of appellant and record on appeal in the case of State v. Joseph Wadell Dunbar. Also on Friday, August 2, 2013 counsel filed the initial brief of appellant and designation of matter in the case of State v. Romeo Brown. Also on Friday, August 2, 2013 counsel filed the Anders brief of appellant and record on appeal in the case of State v. Prentiss Love. On Thursday, July 25, 2013, counsel filed the petition for rehearing in State v. Antwan McMillan. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Butler Gatson on Wednesday, July 24, 2013.




4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


