

Also on Friday, August 2, 2013 counsel filed the initial brief of appellant and designation of matter in the case of State v. Romeo Brown. Also on Friday, August 2, 2013 counsel filed the Anders brief of appellant and record on appeal in the case of State v. Prentiss Love. On Thursday, July 25, 2013, counsel filed the petition for rehearing in State v. Antwan McMillan. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Butler Gatson on Wednesday, July 24, 2013.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.




