I, Khalil Divine Black Sun Allah, as principal (the "Principal") have this day appointed Emily Claire Paavola to serve as my agent ("Agent") and to exercise the powers and discretions set forth below.

Statement of Intent to Create Durable Power of Attorney

By this instrument I intend to create a Durable Power of Attorney under South Carolina law – S.C. Code Ann. § 62-8-101 *et seq.* for the purpose of granting the powers and discretions described below. This power of attorney is immediate and shall not be affected by my subsequent incapacity or by the lapse of time.

Agent Authorization

Ms. Paavola is authorized as my Agent to elect a method of execution, pursuant to S.C. Code Ann. § 24-3-530 (2021), on my behalf.

My Agent is fully authorized and empowered to perform any acts and to execute and deliver any documents, instruments, certificates and papers necessary or appropriate to exercise the authority I have granted to her through this Durable Power of Attorney. This includes signing the election form on my behalf and electing the manner of execution in writing fourteen days before any execution date, as set forth in S.C. Code § 24-3-530.

My Agent is authorized to make photocopies of this instrument as she may deem appropriate. Each photocopy shall have the same force and effect as any original.

All persons from whom my Agent may request information regarding me, my personal or financial affairs, or any information which I am entitled to receive are hereby authorized to provide such information to my Agent without limitation and are released from any liability whatsoever from me, my estate, or my Personal Representative for complying with my Agent's requests.

It is my intention that the authorizations granted herein shall be given the broadest possible construction permitted by law. I further declare that any court or individual that shall interpret or construe the grants of authority made in this power of attorney in any restrictive way shall do so in clear and complete violation of my express intent and in utter disregard of my wishes. I declare that I have been advised by counsel of the breadth of the delegation I have made in this power of attorney and that I understand it and desire it.

This instrument may be amended or revoked by me at any time by a written statement of revocation, amendment, or removal, signed by me and delivered to my Agent.
