I think you spoke with my law partner and he consented to the extension, but if not we certainly consent.

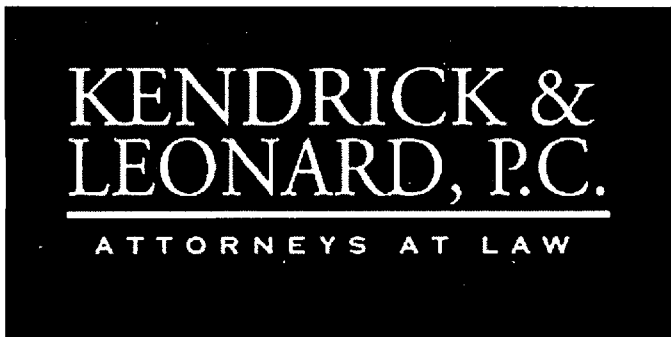
