

NOTICE OF APPEAL

Marques Quantez Heath appeals his conviction and the sentence imposed by the Honorable William A. McKinnon. On August 21, 2024, the Appellant was found guilty of Murder, two (2) counts of Attempted Murder, two (2) counts of Kidnapping, four (4) counts of Possession of a Weapon During the Commission of a Violent Crime, and one (1) count of Assault and Battery 1st degree. The Appellant was sentenced to Life on the charge of Murder (Indictment No. 2019-GS-46-01192), and consecutive sentences of thirty (30) years on the attempted murder charges (Indictment Nos. 2019-GS-46-001232, 01234). The Appellant was also sentenced to concurrent sentences 30 years on the Kidnapping charges (Indictment Nos. 2019-GS-46-01225, 01226). He was also sentenced to ten (10) years concurrent on Indictment No. 2019-GS-46-01229) and 5 years concurrent on Indictment Nos. 2019-GS-46-01192A, 01224A, 01232A and 01234A). The Appellant was also convicted of Kidnapping (Indictment No. 2019-GS-46-01224) and received a sentence of zero (0).


