Dear Clerk of Court,

I am writing to request clarification on the Court's order issued on August 29, 2024, concerning the following matters:

1. Motion for Extension of Time: The Court's order did not address the second part of my Motion, which seeks an extension of time to file the Initial Brief and Designation of Matter. In light of the Court's ruling that summary court transcripts are not required, I need additional time to revise my Initial Brief and Designation of Matter to exclude the Magistrate Court transcripts. I respectfully request an extension to accommodate these revisions.
2. Appeal Bond and Stay: The Court's order acknowledged that it did not fail to consider the Magistrate's issuance of a stay and the setting of an appeal bond already filed on this case. However, it also stated that "Appellant has not received a stay from this court" and cited S.C. Code Ann. § 27-40-800(e)(1) regarding the stay of execution of a judgment for ejection. The Clerk of Court of Common Pleas of Sumter County directed me to the Magistrate Court for the appeal bond, which has been filed. Could you please clarify if the appeal bond issued by the Magistrate Court is sufficient, or if there are additional requirements to redirect the bond to the Court of Common Pleas or the Circuit Court Judge, as outlined in the cited statute?
