On August 16/2024. I received a deficiencies letter in regards to the Proof of Service not being correct. I never received any correspondence from the Court of Appeals in regards to the Notice of Appeal. I filed the Notice of Appeal on Charleston County Clerk of Court on August 9/2024 after the courts were closed for 82 hours during storm Debbie. My phone calls and emails to the Court of Appeals for clarification about the process, as well as if Charleston residents would be given additional time to file documents, seeing as though the courts were closed. My phone calls and emails were never returned August 4-8/2024. On Aug 16 the Court of Appeals stated I had 10 days from the date of the letter to serve the proof of service. Of the Notice of Appeal. The Proof of service was served and filed on Aug 20/24. Today I received a informed delivery notice from USPS of a letter from the Court of Appeals. Saying the Appeal filed on Aug 5/2024 was dismissed. As stated above I was never informed by Jacqueline the case manager or the court of in writing that there was an issue with the Notice of Appeal.

I contacted the court of Appeals last week Monday - Friday. On Friday August 23/2024. I was told for the 5th day in a row that Jacqueline was not there. I asked to

Speak with her supervisor. A woman named Stormie alleged she was Jacqueline supervisor. She stated the proof of service was in the system and was accepted. She stated there were no other issues with case.
