I am appealing the probate court decision dated June 5, 2023. I believed I was initially appealing the decision on June 6, 2023 when I went to the Supreme Court of SC Office of Disciplinary Counsel and filed a complaint against Judge Jacqueline D. Belton and the probate court because of their unethical court practices which lead to this unjust decision.

I am a 100% service-connected disabled USAF veteran and my father had dementia. I'm not just fighting for me, I'm also fighting for him and every disabled, handicap, Alzheimer's and dementia person out there to keep them from being taken advantage of too. I have a draft of a notice of appeal I believe was filed with the ODC. I also believed that since this case was still open that it may not have been necessary to file any other paperwork until a decision was made regarding Judge Belton, who I believe should have recused herself and the probate court since they were giving legal advice and telling me to wait and do nothing, when I should have been advised to keep seeking legal assistance. I truly believed they were going to be found guilty. While I was waiting for the decision to be rendered, I was being sabotaged every step of the way. My cell phones continued to be illegally hacked into by the ODC, the FBI, the Police, the VA, the Army and other hackers that were and are trying to prevent me from getting JUSTICE or any part of my father's estate I recently went to the Dept of Justice because of the civil and human rights violations. I was involuntarily committed to the psych ward of the VA and Prisma healthcare psych ward on three separate occasions within a 6-month period, ordered by your probate Judge McCullough and police and ems unit. I was physically assaulted by my uncle and had been physically ill each time I was committed to the hospital. I was caused a great deal of harm, medicated against my will and given psychiatric diagnoses that were untrue. I was also prevented from getting legal representation the same way I was prevented from getting it initially. My cell phones are being illegally hacked into and I'm not only being prevented from getting legal representation, but anything else I need to prevent me from fighting and/or to make me look incompetent and crazy. I was being

mistreated in a residence I rented prior to this one at 230 Deer Hound Trail, there were a myriad of problems from theft of personal property, illegal drugging rendering me dysfunctional, and I was not allowed to get anything in my name, renters insurance, car insurance, life insurance etc., I was only allowed to pay rent and utilities but never allowed to get anything else in my name there. I also had problems with my mail there. The owner was receiving the majority of his mail there. I wasn't even able to get my license information changed over, so it basically looked like I never lived there. And I believe I was molested there. My rights were being violated with illegal monitoring. I wasn't even given an application to fill out. Back and forth with Richland county sheriff's deputies and police reports that had to be corrected constantly because of all the misinformation that was put in these reports practically consumed a lot of my time as well as trying to get my car on the road so I could travel to NJ to visit my son, until this day, I haven't seen him in 19 -20 months and I've haven't spoken to him in approx. 5-6 months or more, this is being done I believe to break me. I've been running around trying to get the help I need, from the police, FBI, Senators, the Governor and other government agencies. I had to find a place to live, relocated and am currently experiencing some similar situations here. I provided documentation to the ODC, which I am enclosing with this document. I am going to try and give you a brief synopsis of what they entail.

I was homeless in California, surviving in hotels, there was always a way to contact me, through my son or his father. I didn't even know my father was that ill, until I got the dreaded call about his death. I had been trying to keep in contact with my family, especially my dad. My sister changed her phone number and they also changed my dad's number. I couldn't understand why they would not contact me and provide a solution to his care and my homelessness.

I was in the process of relocating before this occurred. There are a number of things I like to bring to your attention, there were approximately 2-3 wills. One, which did not even include me, and being my father's favorite, I found this to be quite odd. When I came down for the funeral, I was treated very poorly by my sister and not even allowed to stay in my father's home, by his girlfriend. My son and his picture were excluded from my father's obituary, my name was changed to Janice Palmer vs Janet Palmer-Carri, there happens to be a Janice Palmer in Richland county. I was not allowed the opportunity for conservatorship over my father's estate, A copy of my fathers will was sent to a UPS box in California yet I had already relocated and they knew this. My finances were held up by the VA for approximately a month or more. The VA sent personal service information to this location as well, information like date of service, branch, disability, rating etc., as well a compensation check, Henrietta Palmer, my uncle's wife, stated she had been speaking with Judge Belton and asked me if I would be okay with just me, Renee and Rosetta being sole heirs to my father's estate initially I agreed but changed my mind and believed it should only be me and Renee. Refer to the enclosed documentation. Henrietta also gave me the Judges number to call her since they were attempting to exclude me. Henrietta never told me she was in the will or my uncle Bobby or their son Michael and if all three of them were granted this decision they would get more than all of us collectively. I found out later when I was able to view the will for myself, what it contained. I called and Judge Belton's home and her daughter answered stating she was out of town. I was also told by Renee to not get a lawyer, she had everything under control and that me, her and my niece would be put in as sole heirs. I disagreed with the niece but she said it could be

changed later and that she had to go in the will because it was a state law and that Rosetta could not be put in the will because she was never legally adopted but since Renee was contesting the will I was told by Stanley Law group that my niece did not have to be put in the will. My sister Renee also stated she had conversations with Judge Belton, this obviously is unethical, conversations regarding my father and his estate and Henrietta and Bobby Palmer using my father as a "Cash Cow". I was forced into a mediation hearing but not allowed to say anything, I told them I was not agreeable to the mediation hearing or negotiating since I had no legal representation of my own and I was made to read and sign an agreement stating Mr. Parker was only representing Renee and asked to leave the room whenever he spoke with her. Once again, I was left out there without any say. At that time, I was told 2 of my relatives died and the funeral was that weekend. My father should have been taken to an attorney to draw up a will and not a hardware store. During the mediation I found out Bobby and Henrietta Palmer had received a large sum of money from the sale of my father's businesses in the South. And finally, how is it possible that a girlfriend, not his wife is entitled to any money at all? And how is she entitled to more than me, his daughter. I would never agree to anything like this. I believe my father had a larger estate and it was illegally taken by family members and his girlfriend. I attempted to hire Stillinger Investigations to find out what happened to all my father's money, antique cars and property also his construction equipment, I was told by Renee that she gave my Uncle Raymond some of my father's equipment, this same uncle who assaulted me, without my permission. My father was a multi-millionaire not just a millionaire, so where's all his money? Also there's supposedly a tax issue, I was told my dad had not paid taxes for several years, but from the documentation I viewed he had taxes due in the amount of \$4,795 for the tax year 2022, which my sister said had been paid. I find it hard to believe that the state of South Carolina or any other state would allow someone to go that long without paying taxes and not seizing their property, obviously something else is or was going on. I don't believe this to be true, my sister told me in the beginning that she was making sure everything was paid up to date because she didn't want my father to owe anything and I thought it might be possible that the state may be involved in something fraudulent if this were the case in retaliation against me for protesting at the superior court with picket signs stating that Judge Belton and Judge McCullough should be disbarred. I was conveniently involuntarily committed to the psych ward of the VA after stating to the sheriff's deputies after my uncles assault on me that I was going to protest against them and sue the Fairfield County police and contact AL Sharpton and the ACLU. All of which I did while in the hospital and out. I don't believe my father would have ever put a clause in the will about anyone who contest it would get nothing and I also believe that if he had been taken to a lawyer he would never have been taken advantage of. I was sent a notice of final disposition regarding Judge Belton, finding her not guilty. This letter was sent to my sister's house, at 424 Boney Road, where I was receiving my mail. This letter was dated March 25, 2024, I never received this letter until last week after visiting the ODC and speaking with Ms. Erica Williams to find out what was going on with the case. She wouldn't tell me but sent the letter to my new address on Mallet Hill Road. It took 9 months for them to make this decision? And I sure I changed my address with them when I resided at 230 Deer Hound Trail, so why wasn't it sent there, and I've talked to my sister on several occasions since then, but was never told about any mail or even given any mail that may have come there. I originally prepared this document on August 12, 2024 and was sickened on purposed on August 13, 2024, which prevented me from getting this to you

sooner. I have gone to and called so many attorneys, yet I am forced to do this myself, I've been given a little legal advice, here and there but never represented. I've been told it would cost me approx. 3x the amount my sister paid and taken advantage of paying consultation fees, see document filed with the ODC regarding Snell and Snell. I have yet to file a complaint against Snell and Snell, Judge McCullough and Parker Law. When this all began I sought legal assistance and even called Parker Law not knowing that my sister hired him and was told there was a conflict of interest. Obviously, no one had my best interest at heart so here I am made to fight myself. I believe that justice would best be served if me and my sister Renee were made sole heirs to my father's estate. I pray you would find in my favor and grant this decision. If necessary I'm willing to take a lie detector test and furnish you with Judge Belton's phone number and any other evidence I can dig up. A lot information about my father's estate has been kept from me and my sister's been avoiding me. Also, his estate value seems to have conveniently decreased, according to the paperwork I viewed.

If any monies have been dispensed, I have not received a penny to date.
