
PETITIONER’S MOTION FOR EXTENSION OF TIME TO FILE REPLY BRIEF

This Motion of the Petitioner seeks an Order of this Court, extending the time to file its Reply Brief in the above-captioned appeal (“Appeal of the Manning Order”). The ground for this Motion is that Respondent Stevens & Wilkinson has requested an extension of time to file its Brief of Respondent in the appeal in a companion appeal: Stevens & Wilkinson of South Carolina, Inc., Gary Realty Company, Inc. and Garfield Traub Development, LLC v.
