**MOTION TO EXPEDITE AND TO REQUIRE CONTEMPORANEOUS SERVICE  
USING THE SAME MEANS**

---

The Respondent hereby moves that this appeal be expedited without any further extensions for either party. *See* Jean H. Toal *et al.*, *Appellate Practice in South Carolina* 375-76 (3d ed. 2016), citing *George v. Mun. Election Comm'n of City of Charleston*, 335 S.C. 182, 184, 516 S.E.2d 206, 207 (1999); Rule 263(b), SCACR. A quick scan of the C-Track entries for this appeal (attached as Exhibit A) shows that the notice of appeal was filed over a year ago on August 21, 2023. The briefing still has not closed. Appellant has moved for seven extensions to date.

In addition, Respondent asks that Appellant be ordered to copy the Respondent on any written communications with the Court using the same means used to communicate with the Court, be they by email or more traditional correspondence. Respondent either receives very late notice

of Appellant's motions or no notice at all. Respondent has repeatedly asked to be copied; however, Appellant continues to seek extensions without copying the Respondent.

For example, as shown in C-Track, the last "motion" for extension came in the form of an email to the Court's filing address dated September 3, 2024. The email did not include counsel for the Respondent, nor did it include a certificate of service. Respondent first learned of the motion when it was granted on September 4, 2024.

The briefing in this matter has dragged on long enough. Respondent asks that this motion be granted, that no further extensions be provided, and that the Appellant be required to copy Respondent on any communications with the Court using the same means used to communicate with the Court.
