MOTION FOR AN EXTENSION TO SERVE AND FILE
THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for De'Andre Murphy respectfully requests a **final thirty (30) day extension, from September 13, 2024, until October 14, 2024**, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

number of extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.



Xavier Polite with the Court of Appeals on July 17, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Phillip Lawson with the Court of Appeals on July 3, 2024. Counsel was a speaker at the Case Law Update CLE on June 21, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Alonza Marable with the Court of Appeals on June 21, 2024. Counsel filed the Brief of Appellant in the case of The State v. Tommy Long with the Court of Appeals on June 3, 2024. Counsel presented oral argument in the case of The State v. Ricky Bernard Brown before the Court of Appeals on June 3, 2024.

4. Counsel makes this request in good faith and not for purpose of delay.


