Dear Attorney Darryl C. Caldwell,

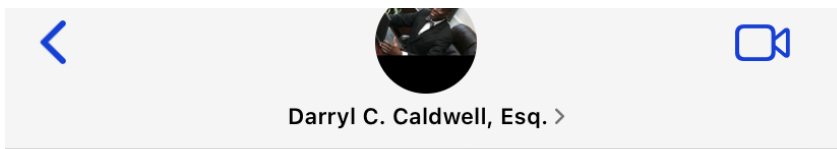
Thank you for representing me in my case: *Florence vs. Secka* CASE NO: 4:21-cv-03746-JD. However, I have decided that I no longer want [**Caldwell Law Firm**] to represent me in this matter.

Please note that your representation is now terminated, effective immediately for failure to follow client instructions to file the initial Motion to Dismiss and enter a Counterclaim on 1/18/2022. 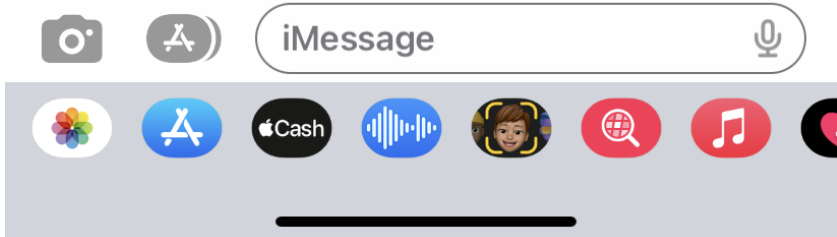
