DESCRIPTION OF OFFENSE: Larceny / Petit or Simple Larceny - \$2,000 or less (Enhancement per 16-1-57)

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on March 10, 2022, in the County of Jasper, City of Ridgeland, one Robby Willie Tracy did commit the offense of Petit/Simple Larceny value \$2,000 or less (Enhancement per 16-1-57). On the day in question, defendant Tracy did enter the property of the Ridgeland Correctional Institution located at 5 Correctional Rd. in Ridgeland, SC 29936 for the purpose of inmate visitation. Upon exiting the RCI Institution defendant did steal and carry away (1) one cellular telephone property of the SCDC and valued at less than \$ 2,000. The cellular telephone was taken unlawfully by defendant Tracy and the theft is captured on video surveillance positively identifying the defendant as the person of the theft.
