Enclosed please find the chapter 33 settlement (33:14 Letter to Clerk advising of settlement) along with **Proof of Service**.

I'm writing you today to inform you that on 8/16/2024 a Mr. Todd Darwin who is a attorney who acts as a representative for South Carolina Department of Corrections. Mr. Darwin came to visit me at Livesay Corrections with a offer in the amount of \$56,000.00 from my prevailing wages money. He placed several documents before me to read. After reading the documents I realize that they was legal contract documents concerning the \$56,000.00 offer. I signed the documents stating that I accept the offer of \$56,000.00. After I signed the (legal) documents Mr. Darwin assured me that I would receive the \$56,000.00 in my cooper account within 10 to 30 working days. By the time you receive this letter the 30 working days will have elapsed and there has not been a deposit into my account which leaves me with some serious concerns. There was two other inmates who signed the same legal documents with Mr. Darwin (48) hours before I signed and they received their money in 12 days.

Mr.Darwin is a outside hired attorney hired by S.C.D.C. . When Mr.Darwin came to visit me with the offer of \$56,000.00 he was acting as a representative for S.C.D.C. We signed legal binding documents between myself and S.C.D.C. I'm sure that your office received notice of this \$56,000.00 offer because I have not received any documentation from the Court of Appeals concerning my brief which was filed in the Court of Appeals on 7/15/2024, over two months ago.

Ms.Kitchings, if it be possible could you please let me know what stage this case is in. If S.C.D.C. is not going to honor their legal contract I need to know so I can prepare for the next legal process.


