


COUNT I: MURDER
(Warrant 2019A2330211364)

That JEFFREY MICHAEL GEORGE did in Greenville County, on or about the 1st day of December, 2019, unlawfully and with malice aforethought kill IVAN GULA. This is in violation of §16-03-0010 of the South Carolina Code of Laws (1976) as amended.

COUNT II: KIDNAPPING
(Warrant 2019A2330211365)

That JEFFREY MICHAEL GEORGE did in Greenville County, on or about the 1st day of December, 2019, unlawfully seize, abduct, confine, inveigle, decoy, kidnap, abduct or carry away IVAN GULA, without the authority of law. This is in violation of §16-03-0910 of the South Carolina Code of Laws (1976) as amended.
