Dear Judge Newman.

As you know, I requested that two of your orders from like May 2024 be added or otherwise dealt with by the Court of Appeals a couple of weeks ago. Think the case numbers end in 5255 and 6054.

Related to those two orders, and I apologize in advance if my memory of exactly how you phrased the captions on those orders isn't exactly accurate, I have a question about those two orders. Same question about both orders. (trying to make sure I get this inquiry to you ASAP in case I am arrested again by the County of Charleston soon)

Those two orders appeared to be trying to combine an order of referral and a rule to show cause together in one order. As you know, I am not an attorney licensed to practice law in this State, but, I haven't been able to find anything else like that. What I am trying to get at is isn't it your job to write and file an order of reference and then whoever you refer a case to isn't it their job to do that whole rule to show cause thing? Similarly, and I'm just asking because I thought all of this worked differently, how did you know to assign these cases to Mr. Stickland for a trial or whatever on 18 Jun 2024?

Thank you for any help you can shed on how this all went down. If I'm not locked up again next week, I will try to make a more formal request of you related to this.
