MOTION FOR ENTRY OF DEFAULT AND

Mr. Darwin placed several documents concerning my prevailing wages case. After the signing of the documents Mr. Darwin assured me that the \$56,000.00 would be deposited into my prison cooper account within ten (10) to thirty (30) days, working days. As of this day, 9/30/2024 the thirty (30) working days has elapsed and no deposit has been made. On 9/24/2024 I wrote General Counsel by way of inmate kiosk. Wherefore, the appellant respectfully moves this honorable court for an order entering a default judgment against the South Carolina Department of Corrections and for such other and further reliefs in favor of the appellant as this honorable court deems just and appropriate. Appellant signed legal contract documents with SCDC and wishes to be paid \$56,000.00 which was agreed upon on 8/16/2024.


