Further, please accept this letter and the following as my compliance with Rule 203(d)(1)(B)(iv) requirement for a written explanation showing issue to be reviewed on appeal:

Mr. Wilson demanded that I file an appeal to his sentence following his guilty plea on August 26, 2013. The presiding judge rejected the State's plea offer of five (5) years active sentence in SCDC followed by probation and payment of restitution to be run concurrent with any revocation of his current probation case. Instead, the presiding judge sentenced him to eight (8) years active time in SCDC with no probation to follow and civil judgments on all restitution to be run concurrent with the full revocation of his probation, which was also terminated following such revocation. During the plea as well as after the sentence, there were no motions or issues raised or ruled upon by the Court. Therefore as an officer of the Court I do not believe there are any meritorious issues to be reviewed on appeal. Mr. Wilson believes that he has a legal right to appeal his conviction and I am doing so at his instruction.
