**REQUEST TO EXTEND FILING FEE DEADLINE & UPDATED STATUS REPORT - DUE
TO EXTENDED HOMELESSNESS AND NATURAL DISASTER**

Due to my continued homelessness and living from my car & rental storage unit
Since the bond hearing on September 25, 2025 there have been several events that hindered my ability
to secure funds or internet access as a direct result of Hurricane Helene and extended power outages.

This made sleeping in my car, accessing public facilities, finding gas to travel to & from my work
assignment in Greenville and finding a place to shower & eat more complicated.
This has brought on additional stress & mental decline as my mother/family lives in Florida.
The fact that my place of employment lost power 6am September 27, 2024 to the following week,
resulted in my having to walk up & down 4 & 5 flights of stairs assisting guests to their rooms in a sold
out hotel because the elevators were out. This took a toll on me physically & mentally. This
unexpected natural crisis hindered my ability to follow through on going to the bank to attempt to
borrow funds to pay necessary bills, court filing fee, and other fees required to comply with my Appeal
Requirements.

At this time I do not have any funds to pay the \$250 Filing Fee or any other fees.

On multiple occasions last week, I have also reached out to Mr. Vince Price by phone for the sake of
time to inform & request an extension on the funds he is requiring to settle this Life Changing
Disruption of my personal life & health with no response back to this moment. Being that I complied
with the Sheriffs Verbal Instructions giving by phone after 530pm on Friday, 8/23/24 to remove my
belongings from the property by the next morning as instructed on the 24hr Writ of Ejectment Notice
placed on my door. I did just that to avoid having my personal property being put out on the curb and
did not want to take that chance because I did not receive the email with the stamped copy of the
Appeal Request, Motion to Stay & Motion to Waive the Filing Fee until 830am on Monday, August 26,
2024.
