STANCES


BOBBY JOE BARTON, being duly sworn, deposes and says:

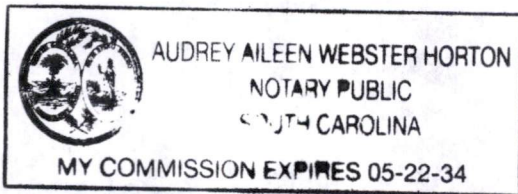
