Motion to Clarify deficiencies on the record

Let the record reflect I was kidnapped by Sheriff department & held hostage & threatened & coerced for over 30 days without jurisdiction while in & out of psychosis and denied mental health treatment the trial was done in my absence due to being in & out of psychosis due to the stress of trial 7/30/24 I have PTSD, bipolar, Anxiety & psychosis I tried to put in a defence on the merit stating I am incompetent and letting them know I was incompetent after signing my PR bond which Marcus Smith did receive on 10-19-24 when he got the case and I found out I was taken unwarranted / kidnapped 12 days The South Carolina Court of Appeals has had jurisdiction in this case from 8/7/24 - 9/28/24 According to the two deficiencies letters sent out on Aug 7 2024 & Sept 18 2024 District & state cannot have jurisdiction at the same time I was picked up Aug 19, 2024 - Sept 26 2024 I have been in & out of psychosis during the trial & while in the detention center I have already been held 12 days through mental health probate court 8/10/22 - 8/22/22 which violated my 10 day preliminary hearing because I was kept 12 days which was unwarranted confinement violation of due process / kidnapping because I wasn't released after signing my PR bond this double jeopardy to be confined in probate mental health & criminal for the same offense the judge also sentenced me on the same day as I was found guilty & his sentence was concealed so District Court have not had jurisdiction to sentence me & I was never mailed mental health patient's don't serve time they get treatment so that cannot be added to my sentence

The Judge didnt Follow "Fitness to stand trial"
& tried me in my absence when I am Incomptent
to stand trial which was proven 8/10/22 after signing
my PR bond & I got Approved For disibity in July 2024
Fully Favorable mentally disabled the Judge Never asked
for a Judicial "re-examination" I was taken 8/8/22 &
8/10/22 by Police to Prisma Health For an emergency
admission & the the Judge Never dropped Any of my
Charges on 7/30/24 I was Charged For 6 charges
which I Appealed on a Interloctory 7/31/24 & while I
was at the Detention Center on void charges of
bench warrant which I was threatened & corcied to
attend a "trial" in which I was unfit to stand trial
prose which I requested & my Family also request that
I be sent to a mental Facility to relieve mental Health
they were denied & I was also denied I tried to Kill myself
while there & mental Health told me "owell" due to me
being locked in the shu and I was given the wrong meds
this is against the SC law that states "Mental patients
shall Not be kept In Jail For safe keeping" I have Not
been to court For this matter because the district court
Diant / Dont have Jurisdiction From 8/7/24 - 9/25/24
I have illegally & unjustly sent to prision with 3 charges
stating 8 years when district court havent had
Jurisdiction to drop any charges & All charges should
have been dropped due to due process violation and
12 days unwarranted confinement & double depordy Due
to being unsustly transported to prision I ask For more
time extention than 10 days And being locked in
a cell & Not having access to mailing in a timely manner

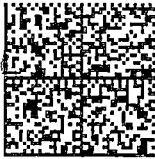
