Only one officer was scratched minor No other officers was insured which I had a busted lip, loose tooth, hand & arm and knee was bloody I was mobbed by 5 officers For requesting to speak to a superior and they persued me on the basis of basis of mental health & called ems I was harrased on the basis of mental health which they triggered PTSD & bipolar & anxiety by persuing me & my child & mobbed me when I refused emergency exam via ems I stayed in Marsha Pickens 12 days found incompitent after signing pre bond on 8/10/22 which was added in falseified sentence (12 days) 8/10/22 - 8/22/22
