**NOTICE OF APPEAL**

Cynthia-J: Glenn <sup>TM</sup> appeals the judgment of Alex Kinlaw from hearing dated October 10, 2024. Appellant received verbal notice from the judge that she was not allowed to finish her presentment by Special Appearance for the Challenge of Jurisdiction, Dispute of Fraudulent Lis Pendens and Demand for Expungement on October 10, 2024. On October 11, 2024 orders were posted stating that Cynthia J. Glenn <sup>TM</sup>, Defendant, was not present and the matter of jurisdiction was dismissed. Appellant filed the motions under case number 2024LP2300640; however, the court has the motions listed under associated case 2022CP2301799. This appellant challenged jurisdiction on the Lis Pendens based upon lack of jurisdiction on the associated case.

Whereas this appellant raises a challenge of jurisdiction under Rule 12(b)(1),(2),(3),(4),(5)and (7) and Jurisdictional bars "may be raised at any time" and courts have a duty to consider them, WILKINS v. UNITED STATES 13 F. 4th 791 and the challenge involves the merits of the actions pursuant to section 14-3-330(1); this appellant now appeals the order of dismissal.
