
4. Counsel makes this request in good faith and not for purpose of delay.

5. On September 29, 2024, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing by


Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through October 31, 2024.
