The following letter addresses the correspondence and actions taken in these cases. The questions asked and information requested is to make sure that I as defendant and appellant in the above cases take the required actions to fulfill the laws and statutes which apply with regard to your status in these cases. Do you have standing in these cases?

Please advise me of your relationship, if any, in/to the above cases. Please provide information as to the reason you are being "copied in" by Deputy Clerk Catherine Harrison on correspondence in the above case. Please state the laws and statutes of the State of South Carolina and the United States which provide your rights, responsibilities, and actions you may take in this case. Please indicate which laws and statutes require me to notify you of the actions in this case and which make any other requirements of me as appellant to fulfill. Additionally, please state the same for the Horry County Circuit Court Case 2020CP2605267. You are still listed as the attorney of record in that case index.

On October 10, 2024, Deputy Clerk Catherine Harrison, South Carolina Court of Appeals, in her deficiency letter to me, wrote the following: "You must serve counsel for Respondent." In that same letter, she copied you in by email. Additionally, Ms. Harrison has copied you in on her letter of October 10, 2024, which assigned the case number noted above to the appeal.

Pursuant to the deficiency letter of October 10, 2024, I am sending you notice that copies of all the documents which have been filed by appellant in this case are present in your South Carolina Court of Appeals ACMS file under the above case number. A copy of this is attached to this letter, and I have printed hard copies and mailed them to you by USPS with the Proof of Service which is also attached to this letter.

In my letter of October 10, 2024, to Ms. Harrison, I asked her to "PLEASE ADVISE ME: Is the former attorney of record, Henrietta U. Golding, required to be served?" This followed the paragraph:

"The counsel for respondent, Henrietta U. Golding, was relieved from the Appellate Case by your own order.
