APPELLANT'S SUPPLEMENT REPLY TO RESPONDENT'S INITIAL BRIEF

Respondent's initial brief states on page 7, beginning at line 21-23, that a proposed order was submitted, to refer the action to Benjamin C. P. Sapp, as Special Referee, on February 14, 2023. There is no record of this "Proposed Order being submitted" via court records. Respondent had this Order prepared and submitted to Judge Carmen Mullen or her Clerk/Assistant. She just signed off on the Order Respondent has already prepared. Please take note of the following:

1) Order that was electronically signed/filed by Judge Carmen T. Mullen¹ has Respondent counsel's, Brock & Scott PLLC file number at the bottom right corner of the Order (B&S No: 15-22471) which the same identical Brock & Scott file number on the Orders that was created by Respondent's counsel on Orders prepared for Judge's and Clerk of Court to sign off on for the Respondent's counsel in this case. 2) Order that was electronically signed/filed by Judge Marvin H. Dukes, III² which has the Respondent counsel, Brock & Scott PLLC file number at the bottom right corner of the Order (15-22471) which is the same identical Brock & Scott file number on the Orders that was created by Respondent's counsel on Orders prepared for the Judge's and Clerk of Court to sign off³ on for the Respondent's counsel in this case. 3) Orders that were created by the Respondent, prepared for Special Referee/Judge Benjamin C. P. Sapp⁴ to sign off on for Respondent's counsel which has the Respondent's file number on the bottom right corner of the Orders^{5,6}.

Appellant's Supplemental Memorandum to Support her Motion for Summary Judgment dated March 3, 2023 has clear, cogent and convincing evidence that support her defense and position. For example, the opposition/reconsideration and or Appeal of Special Referee's Appointment was filed because Respondent circumvent the procedural process by preparing the Order for Judge Carmen T Mullen to sign, while disregarding the legal process that afforded Appellant to participate in the selection process according to SCRCF 53(b) states where the parties consent... Respondent sent a prepared Order directly to the Judge for her signature. She just signed off on the Order. There was no consideration to the Appellant's right to participate. A replacement for Judge Dukes was already in place. On February 26, 2023 Judge H Steven DeBerry⁷ scheduled a motion hearing for March 7, 2023. This was filed and recorded on February 17, 2023. Judge Carmen T Mullen signed the Respondent's Order February 18, 2023. It was not filed into the court until February 21, 2023.


Respondent's initial brief states, "The Special Referee heard the parties perspective motions for summary judgment on May 4, 2023". Respondent further mentions that Vivian Michelle Woods appeared at the hearing on Appellant's behalf. She was not allowed to make arguments for Appellant. He, we have a statement that can be considered an oxymoron. If the Appellant's representative was not allowed to present Appellant's information, how could Respondent claim that the Special Referee heard the parties motions for summary judgment. Appellant has appointed Ms. Woods as her power of attorney and denying her the opportunity to present Appellant's prepared information violated Appellant's right to due process of law. According to the South Carolina Uniform Power of Attorney Act section 62-8-101 (1)(6)(7) and 62-8-203 (1), (3), (4), (7), (8); 62-8-204 (5)b; 62-8-212 Claims and Litigation (1), (2), (6) if the

He then instructed the parties to submit a proposed order by June 5, 2023. Both parties submitted proposed orders by June 5, 2023. The Special Referee signed off on Respondent's order, as usual granting Respondent foreclosure on June 12, 2023, denying Appellant's motions. On June 28, 2023 the Special Referee filed an Order of Foreclosure. Appellant requested reconsideration of the Order of Foreclosure on July 7, 2023; However, the Special Referee denied Appellant's motion to reconsider on September 1, 2023. Appellant filed this appeal on September 5, 2023. Respondent's initial brief misrepresent the facts, even to you. Respondent states "the foreclosure sale was scheduled for November 3, 2023 (October 4, 2023, Notice of Sale). This appeal followed". As you know this appeal was filed prior to the Notice of Sale.


