

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Willie Morrison v. The State with the Court of Appeals on October 7, 2024. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Paul Lamberth with the Court of Appeals on October 7, 2024. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. James Gregory with the Court of Appeals on October 7, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of The State v. Terry Washington with the Court of appeals on September 16, 2024. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals in the case of Devartee Clinton v. The State with the Supreme Court on September 3, 2024. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Tony Williams v. The State with the Supreme Court on September 3, 2024.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that her caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


4. On October 31, 2024, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through November 30, 2024.

WHEREFORE, the undersigned counsel would respectfully request a thirty (30) day extension. Counsel respectfully requests that the time limits for serving and filing the Initial Brief of Appellant and Designation of Matter be held in abeyance pending a ruling on this motion.
