

Attached to this email please find a Notice of Appeal from Charleston County (Case No. 2022GS1000937) and a Notice of Appeal from Berkeley County (Case Nos. 2024GS0803343-45) along with corresponding Proofs of Service. These were served on September 16, 2024 and filed in the respective lower courts the same day.

Mr. Tracy entered a global plea on September 5, 2024 in Berkeley County before Judge Dukes to resolve charges in Berkeley, Charleston, and Jasper Counties. I represented Mr. Tracy for his Charleston and Berkeley County charges and Hillary Futch represented him for his Jasper County charges. My office timely served Notices of Appeal for Berkeley and Charleston and filed the same with the lower courts, but due to a misunderstanding the Notices of Appeal were never submitted to the Court of Appeals. It is my understanding Ms. Futch filed timely with the Court of Appeals and the case has already been assigned to appellate counsel.

Please advise what else is needed from me at this time to consolidate the Charleston and Berkeley County indictments into this appellate proceeding.
