



## ORDER

On February 8, 2024, we dismissed this appeal because Appellant failed to file an initial brief that complied with Rule 208 of the South Carolina Appellate Court Rules. Thereafter, on April 30, 2024, this court reinstated the appeal and ordered Appellant to file an amended initial brief that complied with Rule 208. On August 2, 2024, Appellant filed an amended initial brief. On September 17, 2024, Respondent moved to dismiss this appeal because Appellant's amended initial brief failed to comply with Rule 208 in that it failed to contain sections setting out the standard of review and arguments supporting the appeal.
